## Express Scripts Pharmacy to No Longer Stock 32 Medications

**Effective Oct. 1, 2024**, Express Scripts Pharmacy will no longer stock 32 medications — including Arnuity Ellipta, Entresto, Savella, and Trintellix — across all lines of business. See the full list below. These changes are in addition to the medications discontinued by Express Scripts (ES) on Aug. 19, which can be viewed [here](#).

Members currently receiving impacted drugs will have the option to fill an alternative drug via Express Script home delivery, but those who want to or need to continue filling the impacted drugs will need to do so from ***an alternative, in-network retail pharmacy***.

If members have filled an impacted drug in 2024, they will receive a communication from Express Scripts notifying them 30 days in advance of the change. If a home delivery order is placed for an impacted drug after Oct. 1, Express Scripts will conduct outreach to the member and/or prescriber. The ES team will support finding a covered, clinically approved alternative or direct the member to utilize an in-network retail pharmacy of their choice.

Express Scripts Pharmacy values its retail pharmacy partners and believes these pharmacies are well-positioned to handle the anticipated and limited increase in volume based on this change. Several in-network retail pharmacy partners also offer home delivery options for patients who may be unable to pick up their prescriptions in person.

### Member and Prescriber Communications

- Impacted members will receive a letter or email from Express Scripts Pharmacy to inform them of the change about 30 days before the effective date.
- Express Scripts Patient Care Advocates will be prepared to take calls from our members should they have follow-up questions.
- Prescribers will be contacted by Express Scripts Pharmacy if the member attempts to fill an impacted drug once it is unavailable.
