## **Utilization Management of Outpatient Speech Therapy Moving to Helion Arc**

Attention Highmark Blue Cross Blue Shield (WNY) and Highmark Blue Shield (NENY) providers:

**Effective February 1, 2024**, Highmark is moving utilization management (UM) of outpatient speech therapy to Helion Arc. This change will result in faster approvals for prior authorization requests, **submitted electronically**, for appropriate services.

Helion Arc is integrated with the Predictal<sup>TM</sup> Auto Automation Hub and enables offices to submit, update, and query medical authorization requests. The application supports the management of members' care from end-to-end — including submission, case review and decision-making, and prescribed treatment programs.

While this process does represent a change in the way that providers request prior authorizations for outpatient speech therapy services, the goal is to minimize provider disruption and ensure that the transition to Helion Arc is as seamless as possible.

#### **Submitting Authorization Requests via the Provider Portal**
