UPDATES TO MEDICARE ADVANTAGE REIMBURSEMENT POLICIES TO INCLUDE DELAWARE

Starting on **January 1, 2022**, Highmark Medicare Advantage products will be available for members in the Delaware region. Highmark reimbursement policies that currently apply to Medicare Advantage will be reviewed and updated to reflect if they apply to Delaware Medicare Advantage products and any Delaware specific information.

To determine if the policy applies to Delaware Medicare Advantage, look for an “X” in the Delaware box in the header of each policy (as shown below).

DELAWARE PROVIDERS: Prior to **January 1, 2022**, you can expect to see several reimbursement policies related to Medicare Advantage appear on the **Reimbursement Policy** page of the **Provider Resource Center**. Ensure you review the policies for any Delaware specific changes that may impact you and your practice.

PENNSYLVANIA AND WEST VIRGINIA PROVIDERS: Prior to **January 1, 2022**, Delaware specific information may be added to the Medicare Advantage reimbursement policies you use today. These changes do not apply to your service area and will not affect you or your practice.
