WHAT IS WELL360 DIABETES MANAGEMENT - POWERED BY ONDUO?

Highmark is collaborating with Onduo to deliver the Well360 Diabetes Management program that:

- Is a virtual diabetes care program with tools, coaching, and clinical support to help members manage
 Type 2 Diabetes anytime.
- Provides testing supplies and monitors to participating members, including Continuous Monitors (CGMs) to those who qualify.
- Utilizes a virtual model where every enrollee has access to telehealth services including a Care Lead (health and wellness coach), Certified Diabetes Care & Education Specialists (CDCEs), and an Endocrinologist, if qualified.

This continuous, day-to-day support between appointments is especially helpful when members have questions about daily habits, exercise, and how certain foods affect their blood sugars.

The program is designed to be an extension of the member's primary care and does not replace their primary care physician (PCP).

WHAT ARE THE CLINICAL CONSIDERATIONS?

- Onduo Diabetes follows the American Diabetes Association standards of care
- Onduo Diabetes aims to bring more continuous care and day-to-day support between doctor's appointments (especially related to food and exercise) through three levels of care:
 - Level 1: Care Leads general health/wellness coaching support
 - Level 2: Certified Diabetes Care and Education Specialists (CDCE's) inquire about and encourage adherence to care plan, assess educational needs, educate members (including testing & medication)
 - Level 3: Endocrinologists supervise CDCEs, provide clinical guidance, and may conduct telemedicine visits with members, if necessary
- Blood glucose meters (Telcare) and testing strips are free for all users
- Continuous Glucose Monitors (CGMs) are available to all those who qualify clinically



WHAT ARE THE PROGRAM ELIGIBILITY AND ENROLLMENT REQUIREMENTS?

Who is eligible?	Patients 18+ with Type 2 Diabetes
Who is ineligible/excluded?	Those with a history or diagnosed with any of the following conditions:
