

FACILITY BULLETINS RELATED TO PURCHASED SERVICES END-DATED

Information Transitioned to Reimbursement Policy and Provider Manual

The publication of new Facility Bulletins was discontinued in 2015; however, Facility Bulletins published in prior years remained available on the Provider Resource Center as an information source for facilities. We are currently reviewing all Facility Bulletins to determine whether they should be end-dated or archived. Information that is still valid will be transitioned to reimbursement policies or to the *Highmark Provider Manual*, unless it is already available in another resource (e.g., Medical Policy). The end-dated bulletins will remain accessible on the Provider Resource Center for historical purposes. "Courtesy" bulletins, such as those announcing annual holiday schedules, will be archived.
