PRESCRIBING ANTIBIOTICS

As we approach Antibiotic Awareness Week (November 18-24, 2021), Highmark wants to take this opportunity to raise awareness on the appropriate use and prescribing of antibiotics.

The Centers for Disease Control and Prevention (CDC) has found more than 2.8 million antibiotic-resistant infections occur in the U.S. each year, and more than 35,000 people die as a result. Highmark and the CDC are urging providers to prescribe antibiotics only when necessary. This will help fight antibiotic resistance and the spread of superbugs to better protect members from antibiotic-related adverse drug events.
