





Provider Portal Access

Highmark DE has partnered with Wayspring, an independent company, to offer their axialHealthcare Risk Mitigation Solution to provide analytics and evidence-based support that may reduce opioid misuse. One key resource available to providers through this partnership is the "Pain Management Program Portal," which you can access through NaviNet or via authenticated email access.

- To access via NaviNet follow these steps: From your Highmark NaviNet® portal under Workflows for this Plan, select Auth Inquiry and Reports then Pain Management Program Portal. From there, select the appropriate Billing Provider and Service Provider and click Submit.
 - This will bring up the Dashboard View The dashboard provides different components that bring awareness to your opioid prescribing patterns and opportunities to improve patient care and safety, including:
 - A **RIM Score Preview** This section previews your Risk Identification and Mitigation (RIM) score and the two patient cohorts (Chronic Opioid Use and Acute Opioid Use) that contribute to your score.
 - B Patient Notifications This section provides a preview of the number of patients in your patient panel who may have opioid and polypharmacy-related risk factors.


Authenticated User Direct Log In Process

Step 1.

Once your email address has been validated, you can access the portal by clicking the link to the right or visiting practice.axialhealthcare.com.

You will be prompted to enter your email address, which will trigger email delivery of your unique authorization sign in code.

An email containing a secure 6-digit authorization code will be delivered to the email you provided.








Authenticated User Direct Log In Process
