

Handling of Blood Lead Levels

Children are considered to have Elevated Blood Lead Levels (EBLL) at $\geq 5\mu g/dL$. If a child's level was achieved via a capillary test, the level should be confirmed via a venous draw.

If the level is $\geq 5\mu g/dL$ by venous draw, siblings in the home should also receive lead testing, even if previous tests showed that their levels were within normal limits. It should also be completed even if they are above the age of typical EPSDT testing ages.

All members with an elevated blood lead level should receive ongoing tracking through two methods:

- 1. Referral to Early Intervention or DART for tracking services. This can be done through the CONNECT Helpline at 1-800-692-7288.
- 2. Additional developmental screenings by the provider to ensure that the member is achieving developmental milestones on time.

Children with an Elevated Blood Lead Level should be referred for an Environmental Lead Investigation.
