**IMPORTANT REMINDER:** All providers must revalidate the Medical Assistance (MA) enrollment of each service location every 5 years. Providers should log into PROMISE to check the revalidation dates of each service location and submit revalidation applications at least 60 days prior to the revalidation dates. ### **PURPOSE:**

The purpose of this bulletin is to advise providers of the updates to the evaluation and management (E & M) procedure codes on the Medical Assistance (MA) Program Fee Schedule, as a result of the 2023 Healthcare Common Procedure Coding System (HCPCS) updates. In addition, the Department of Human Services (Department) is also making changes to E & M codes currently on the MA Program Fee Schedule. These updates are effective for dates of service on and after June 1, 2023.

### **SCOPE:**

This bulletin applies to all providers enrolled in the MA Program who render services to MA beneficiaries in the MA Fee-for-Service delivery system. Providers rendering services in MA managed care delivery system should address any coding or billing questions to the appropriate managed care organization.

### **BACKGROUND:**

The Department is end-dating procedure codes, updating code descriptions, and making fee adjustments on procedure codes as a result of the 2023 HCPCS updates published by the Centers for Medicare & Medicaid Services (CMS) to the HCPCS. The Department is also making changes to procedure codes currently on the MA Program Fee Schedule.
