SUBJECT 2023 Updates to Childhood Nutrition and Weight Management Services	BY  Sally A. Kozak, Deputy Secretary Office of Medical Assistance Programs	

IMPORTANT REMINDER: All providers must revalidate the Medical Assistance (MA) enrollment of each service location every 5 years. Providers should log into PROMISE to check the revalidation dates of each service location and submit revalidation applications at least 60 days prior to the revalidation dates. PURPOSE:

The purpose of this bulletin is to advise providers enrolled in the Medical Assistance (MA) Program of the expansion of Childhood Nutrition and Weight Management Services (CNWMS) for MA beneficiaries under 21 years of age to include pharmacotherapy as a result of changes to coverage of obesity drugs and updated guidance from the American Academy of Pediatrics (AAP), as well as coding changes as a result of the 2023 Healthcare Common Procedure Coding System (HCPCS) updates.

SCOPE:

This MA bulletin applies to all physicians, certified registered nurse practitioners (CRNPs), physician assistants (PAs), nutritionists, outpatient hospitals, independent medical surgical clinics, federally qualified health centers (FQHCs) and rural health clinics (RHCs) enrolled in the MA Program. Providers who render services in the managed care delivery system should address any coding and payment-related questions regarding CNWMS to the appropriate MA managed care organization.

BACKGROUND:

On December 9, 2022, MA bulletin 01-22-70, titled, "Coverage and Prior Authorization of Obesity Treatment Agents – Pharmacy Services" was issued. The bulletin informed providers of the coverage of drugs prescribed for the treatment of obesity; the addition of the

The Department of Human Services (Department) submitted and received approval from the Centers for Medicare & Medicaid Services for an amendment to our Medicaid State Plan to allow for coverage of drugs used for treatment of anorexia, weight loss, and weight gain, effective January 1, 2023.

On January 9, 2023, the AAP released updated guidelines on childhood obesity (<https://www.aap.org/en/news-room/news-releases/aap/2023/american-academy-of-pediatrics-issues-its-first-comprehensive-guideline-on-evaluating-treating-children-and-adolescents-with-obesity/>). Among the guidelines, the AAP states the following:

- Comprehensive obesity treatment may include nutrition support, physical activity treatment, behavioral therapy, pharmacotherapy, and metabolic and bariatric surgery.
- Intensive health behavior and lifestyle treatment, while challenging to deliver and not universally available, is the most effective known behavioral treatment for child obesity. The most effective treatments include 26 or more hours of face-to-face, family-based, multicomponent treatment over a 3- to 12-month period.
- Evidence-based treatment delivered by trained health care professionals with active parent or caregiver involvement has no evidence of harm and can result in less disordered eating.
- Physicians should offer adolescents ages 12 years and older with obesity weight loss pharmacotherapy, according to medication indications, risks, and benefits, as an adjunct to health behavior and lifestyle treatment.
- Teens age 13 and older with severe obesity (BMI $\geq 120\%$ of the 95th percentile for age and sex) should be evaluated for metabolic and bariatric surgery.

Providers are encouraged to refer to these guidelines when treating beneficiaries with weight management issues.

DISCUSSION:

Historically, CNWMS has consisted of the following services: initial assessment, re-assessment, individual weight management counseling, family weight management counseling, group weight management counseling and nutritional counseling. As a result of expanded MA coverage for obesity treatment and updated AAP guidelines, CNWMS now includes pharmacotherapy for MA beneficiaries under 21. Bariatric surgery is also covered for MA beneficiaries under Early and Periodic Screening, Diagnosis and Treatment (EPSDT). Bariatric surgery requires prior authorization.

The Department encourages providers to ensure that the child has had a recent EPSDT screening or physical exam, as appropriate, to help support the medical necessity for

the initial assessment, re-assessment and any additional CNWMS the child receives. Primary care providers or other providers who conduct the initial assessment or re-assessment and order CNWMS for the child are encouraged to coordinate with the provider rendering those services.

Additionally, the MA Program now utilizes two Place of Service (POS) codes to identify when services are rendered via telehealth – POS 02 (Telehealth Provided Other than in a Patient’s Home) and POS 10 (Telehealth Provided in a Patient’s Home). As a result of revisions announced in the 2023 HCPCS Update bulletin, the Department added POS 10 to all CNWMS-related procedure codes on the MA Program Fee Schedule. In conjunction with these updates, the GT Modifier was removed from procedure code T1015. Therefore, the chart attached to this bulletin has been updated to reflect the POS code changes for CNWMS rendered via telehealth.

NOTE: Provider type 10, specialty 100 (physician assistant) is included because physician assistants can be listed as the rendering provider pursuant to MA Bulletin 01-22-05, 08-22-05, 09-22-04, 10-22-01, 31-22-05, entitled “Billing Procedure Update for Certified Registered Nurse Practitioners and Physician Assistants.”

PROCEDURE:

The Department will make payment for specific CNWMS services rendered by physicians, CRNPs, PAs, nutritionists, outpatient hospitals, independent medical surgical clinics, FQHCs and RHCs enrolled in the MA Program when the services are medically necessary and rendered to MA beneficiaries under 21 years of age who are experiencing weight management problems. Providers must document the medical necessity for any CNWMS in the child’s medical record, in accordance with 55 Pa. Code § 1101.51 (relating to ongoing responsibilities of providers). Providers should refer to the updated chart attached to this bulletin for services rendered on and after September 5, 2023.

All prescriptions for obesity drugs require prior authorization. Providers should refer to MA bulletin 01-22-70 for prior authorization requirements.

OBSOLETE:

MA Bulletin 01-18-09, titled, “Childhood Nutrition and Weight Management Services,” issued July 3, 2018, and MA Bulletin 01-20-06, titled, “Updates to Childhood Nutrition and Weight Management Services,” issued May 26, 2020, are obsolete with the issuance of this bulletin.
